

Approved Establishment of the Local Governing Body of Sandhurst School



Proposals for the constitution of the new Local Governing Body of Sandhurst School on joining the Corvus Learning Trust.

The Local Governing Body will consist of 14 governors:

- i. 10 Co-opted Governors appointed by the local governing body
- ii. 2 parent governors elected by ballot of parents
- iii. 1 staff governor appointed after ballot of school staff
- iv. The headteacher ex officio
